Historical Note

The first court established for Washington County at the time of its creation was the Court of Pleas and Quarter Sessions. This court held original and appellate jurisdiction in civil and criminal cases but not in equity cases. North Carolina at that time (of which Washington County was a part) was divided judicially into six districts, each with a Superior Court of Law and Equity, which, as the name implies, did have jurisdiction in equity cases. Washington County was initially included in the court that met at Salisbury, North Carolina from 1777-1782 and then from 1782-1784 under the court that met at Morganton, North Carolina. In 1784, the North Carolina counties west of the Appalachians were given their own Superior Court of Law and Equity as the Washington District, which met at Jonesborough. Thus, cases will be found in the records that relate not only to Washington County but to other upper East Tennessee counties. Researchers should also be aware then that some early Washington County cases (1777-1784) might be found in the records of those North Carolina courts.

The two-court system inherited from North Carolina was continued in Tennessee under the first state constitution of 1796. A state-level Court of Equity was established with three traveling judges hearing cases in five judicial districts established for Tennessee. That for the Washington District was held in Jonesborough. The additional districts were Hamilton District (held at Knoxville), Mero District (held at Nashville), Winchester District (held at Carthage), and Robertson District (held at Clarksville).

By the early 1800s, the court system was becoming overworked. In 1809, a new Circuit Court system was established in each county, and the old Superior Court of Law and Equity was replaced by a new state-level court named the Supreme Court of Errors and Appeals. This court evolved into the Tennessee State Supreme Court. It heard larger equity cases and cases appealed from the Court of Pleas and Quarter Sessions and Circuit Court. Judges of these courts included David Campbell, John Overton, Hugh L. White, and Andrew Jackson.

The clerk charged with the custody of Superior Court records was titled Clerk and Master. The following are the individuals who held this office until it was discontinued in 1810:

David Allison (1788-1891); Andrew Russell, 1791-1792; Archibald Roane, 1792-1793; Landon Carter, (1793-1794); John Carter (1796-1806); James V. Anderson (1806-1810)

Note: Some records found in this record group were transferred to East Tennessee State University for preservation in 1958. Beginning in the late 1970s, the Archives of Appalachia there processed some of these records. In August 2016, the records were returned to the Washington County Archives. Some boxes and folders may still be labeled "W.C.C.R." (Washington County Court Records) or acc. 18 (accession collection number). Any boxes or volumes part of this processing at ETSU are cross-referenced in the "Note" column of this guide in case a researcher needs to make a connection to records used when housed at the Archives of Appalachia. This will

be indicated in the note field by "A of A" and the specific box or volume number assigned by that archive at the time of processing. Materials may no longer be in the order found at the Archives of Appalachia.

Scope and Content

As a court of equity, the Superior Court of Law and Equity heard cases involving property disputes, estate settlements, debts, damages, divorces, among other cases. It also heard appeals of cases from inferior courts such as the Court of Pleas and Quarter Sessions. The court had sole jurisdiction over cases punishable by the loss of limb or life and cases of greater dollar value than \$50.

Among the types of documents found in the record group are bonds, docket books, minute books, petitions, notices, bills, injunctions, complaints, subpoenas, depositions, exhibits, correspondence, and writs. See series descriptions for more specific details about particular records.

Series A: Bond Book, 1799-1835**Box 1****Series Description**

The bond book gives written descriptions of bonds made in various cases heard by the court, including the names of those subscribing to the bond and the name of the case involved. There are several blank pages. The last page is a subpoena issued in a Circuit Court divorce case. Note: This volume begins under Superior Court of Law and Equity and was then used to record bonds by the Circuit Court clerk when that court replaced Superior Court. Thus, early Circuit Court records are found in it as well. There is no index.

Series B: Case Files, 1784-1819 and undated**Boxes 1-11****Series Description**

The series begins with a casebook covering 1788-1807 and then continues with files of loose court case records from 1784-1819. The casebook contains a list of cases and a chronology of the actions taken in each such as the bill of costs, judgement, publication of the case, etc. There is no index to the casebook. Case files contain such documents as judgements, bonds, notices, subpoenas, etc. The case files are arranged in alphabetical order with the plaintiff's name (the person bringing the suit) given first, followed by the name of the defendant in the case. Cases beginning with "State of Tennessee" or "United States" as the plaintiff indicate that these are criminal cases. Case files include those for the Superior Court of Law and Equity and the Court of Equity-District of Washington. Researchers will find cases from Washington County and other upper East Tennessee counties in the series.

Series Description

See the “Historical Note” at the beginning of this guide for information about the Court of Equity and the Tennessee Supreme Court of Errors and Appeals. The Court of Equity, District of Washington records (Sub-series E.1) consist of an index volume, a minute book, and an order book. These volumes contain the name of a case and actions and judgements taken by the court in the case. The records for the Tennessee Supreme Court of Errors and Appeals (Sub-series E.2) contain miscellaneous court documents in various cases between 1830 and 1835. Documents include bills of costs, injunctions, writs, court orders, etc. These records were originally part of the Washington County Court Records transferred to East Tennessee State University in 1958 and later separated into its own manuscript collection (accession 173). At the time of the return of the records to the Washington County Archives in August 2016, these papers were re-incorporated into Record Group 18, Superior Court of Law and Equity, of which they were originally a part. Researchers will find cases from Washington County and other upper East Tennessee counties included in the series. There is no index to this series.
